- D. Anne Smith from the Menard County Housing Authority said Amy Beshety Illinois Housing Development will be here on August 23, 2021 at 10 a.m. for training on use of the App for the Housing Stock Survey for the Comprehensive Plan they will be doing in the City.

- 1. Water Collector Georgia Ed presented the Water Collector's Report for June 2021. We actually sold 314,000 gallons less water than this time last year. - 2. Water Superintendents Report. The Water Plant treated

approximately 9,515,000 gallons of potable water. Sewer Plant collected approximately 5,340,000 gallons of sewage and discharged 9,840,000 gallons.

3. Toboggan Hill sewer line approval. A motion made by Alderman Gorman seconded by Alderman Sonnemaker to take position of the sewer line from the top of the hill from Cathy Spinner's house to Sheridan. VOTES: Gain, yes; Allison, yes; Sonnemaker, yes; Gorman, yes. Mayor Snyder declared the MOTION CARRIED.

1. The Mayor read the Street Department Report for June 2021.

C. Library

1. Carrie Winkelmann gave the Annual Library Report. A motion made by Alderman Gorman seconded by Alderman Gain to approve the Annual Library Report. VOTES: Gain, yes; Allison, yes; Sonnemaker, yes; Gorman, yes. Mayor Snyder declared the MOTION CARRIED.

D. Zoning

1. Discussion on the TIFF Application for Menard County Fitness & Tanning. Menard County Fitness & Training presented an updated TIFF Application for construction costs of \$60,455.00. A motion made by Alderman Gorman seconded by Alderman Gain to provide Menard County Fitness & Training TIFF money in the amount \$30,500.00 over a two year period of \$15,250 per year. Amended by both a first and seconded Alderman to \$30,000.00 over a two year period of \$15,000.00 per year. VOTES: Allison, yes; Sonnemaker, yes; Gorman, yes; Gain, yes. Mayor Snyder declared the MOTION CARRIED.
