ORDINANCE NO. 2021-15

AN ORDINANCE AMENDING CITY CODE SECTIONS 9-9 OF THE REVISED CODE OF ORDINANCES OF THE CITY OF PETERSBURG REGARDING BURNING REFUSE AND YARD WASTE

WHEREAS, the City of Petersburg is an Illinois non-home rule municipal corporation organized and operating under the Illinois Municipal Code, 65 ILCS 5/1-1-1, *et seq.*; and

WHEREAS, the Mayor and City Council of the City of Petersburg, Illinois have determined that the current hours for burning refuse and yard waste in the City should be changed to better secure the City from out-of-hand burning; and

WHEREAS, the Mayor and City Council of the City of Petersburg, Illinois have determined that it is in the best interest of the City of Petersburg to amend certain sections of the City Code to adjust the allowed burning hours;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Petersburg, Menard County, Illinois, as follows:

Section 1. The preliminary paragraphs set forth above are incorporated herein as a part of this Ordinance.

Section 2. Section 9-9 of the Revised Code of Ordinances of Petersburg, Illinois is hereby amended to read as follows, with the stricken terms to be deleted and the underlined terms to be added:

§ 9-9 BURNING REFUSE AND YARD WASTE.

(C) (2) No burning shall commence prior to 10:00 a.m., nor shall it be allowed later than sunset, except during the calendar months of October and November, during which no

burning shall commence prior to 8:00 a.m., nor shall it be allowed later than ~~one hour past sunset~~ 4:00 p.m.

Section 5: All ordinances and parts of ordinances in conflict herewith are hereby repealed insofar as the conflicting portions thereof are concerned.

Section 7: In the event that any section, clause, provision, or part of this Ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect.

Section 10: This ordinance shall be effective immediately.
